Institute can see the list of students applied for registration through "Institute Login" section and they will have to approve application of each and every students after due verification of the data provided by the students. User ID and Password will be sent to the email address of the Institute. The Institute will have to validate application of all students through the 'Institute Login' latest by 06.10.2018. After completion of online validation, Institutes will have to take a printout of the list of approved students and submit the same along with all signed hard copies of downloaded application forms (branch-wise and year-wise) and self-attested photocopies of eligibility documents (Mark sheet & Admit Card) of the students to the Council latest by 11.10.2018 with a forwarding letter. Eligibility documents are to be stapled with the respective registration application forms.
